4a (Code:) (Expenses \$ 446,736 including grants of \$) (Revenue \$) FOOD AND NUTRITION SERVICES: Iris House provides food and nutrition services to PWLH and the community at large; in 2016, IH provided a total of 7,412 lunches to PWHA, with 6,228 being hot lunches and 1,184 being bagged lunches; 9,223 lunches to community members in need with 8,229 being hot lunches and 994 being bagged lunches. IH also provided 3,109 pantry bags to 246 PWLH clients (Ingredients for 37,308 meals). 5,989 emergency pantry bags were distributed to 3,867 community clients (Ingredients for 71,868 meals.). As well, IH provided 131 nutrition workshops and/or cooking classes to more than 1,424 duplicated participants. Many of the community members we serve are at-risk of HIV through homelessness, substance abuse and/or other risk behaviors. IH provides nutrition education, cooking classes and fitness sessions to at-risk community members both on-site and at other CBOs.

4b (Code:) (Expenses \$ 2,093,965 including grants of \$) (Revenue \$) SCATTER SITE HOUSING PROGRAM: In FY2016, Iris House provided 74 unites of scattersite housing to 96 men, women and their families; through the case management of this program, 20 obtained job training and/or employment and 8 are now living independently.

4c (Code:) (Expenses \$ 2,024,015 including grants of \$) (Revenue \$) PREVENTION: Prevention Education/PrEP and PEP: Prevention education services to those at risk for HIV were provide through EBIs and multisession 101s to numerous target populations, including men and women of color, young men and women of color, MSM, YMSM and WSW and in public schools to teens. CDC EBIS offered in NYC include D-UP, ARTAS and WILLOW, with 155 individuals participating in 17 cycles and one ongoing program. We offered 8 HIV 101 workshops to 96 participants. Our Just For US program offered 8 Cycles of SIHLE and SISTA EBIs, with 80 clients participating. We tested 1,290 people for HIV, 303 for Gonorrhea/Syphilis/Chlamydia and 166 for Hepatitis C. 13 individuals were referred to PrEP, with 7 beginning therapy. We distributed 346,442 male condoms, 27,775 female condoms and 158,750 packs of lubricant through ten businesses, fifteen health fairs and during outreach. Our New Jersey programs offered an additional 286 HIV tests, 16 cycles of various EBIs including WILLOW, SIHLE, SISTA and Nia for with 152 participants, and 151,661 male condoms, 789 female condoms and 4,
